Our list of fees are as follows, these fees are below the current recommended rate set by the Australian Psychological Society (APS). Fees are subject to change and are generally reviewed annually. An out-of-pocket fee, sometimes called a gap fee, is the remaining outstanding cost after your Medicare rebate is applied, should you be eligible.
